I am responsible for knowing and obeying Captain's Hideaway Powersports Rentals, LLC jeep rules and Oklahoma's state and local laws. I have received the official MOTOR VEHICLE USE MAP and have been shown what roads are legal to ride on.

I am personally held accountable for any damage or abuse to the vehicle. Any fees or charges will be applied to credit card on file, submitted to my insurance company, or collected through the McCurtain County Court system.

Although this is a 4WD vehicle, it is not intended to take off road. If there is evidence of off-road travel I will be charged a minimum of \$500 up to actual costs of repairs plus any loss of use. Gravel roads are OK. You are responsible to return vehicle to 4x2 drive.

The Jeep is full of gas, I agree to top of gas before return. Otherwise we'll have to add a service charge of \$40.00 plus cost of fuel.

I am responsible for cleaning the Jeep before returning Jeep on time. I have received a cleaning cloth and wipes. Cleaning entails a thorough washing of wheels, tires, undercarriage, wheel wells, frame and exterior body. Removing all trash from inside of jeep, shaking out floor matts, and <u>WIPING DOWN INTERIOR OF JEEP</u>. If the jeep is not returned clean, there will be a minimum of \$75.00 cleaning fee charged. <u>* Carwash is at PHILLIPS 66 1100 N PARK DR, BROKEN BOW OK 74728</u>

I understand I am allowed to take the Freedom tops off (above driver and passenger only) and NOT THE FULL HARD TOP, if weather is dry and agree to put them back on if weather or mud is at risk getting inside jeep. It is my responsibility to store them safely in the storage bag provided in jeep.

If there is any evidence of mud in control panel or shifter, I agree to pay a minimum \$250 charge up to total cost of repairs and loss of use.
